With reference to the above subject, the proposal pertains to Supply, Installation, Testing & Commissioning (SITC), Training and Comprehensive Annual Maintenance contract of the CCTV Surveillance System at NIHFW, Munirka, New Delhi.

- 1. It is decided with the approval of Competent Authority to install CCTV Surveillance System at NIHFW. Accordingly, NIHFW is inviting commercial proposal only from MHA Notified Central Public Sector Undertakings (CPSUs) i.e. Broadcast Engineering Consultants India Limited (BECIL), Electronics Corporation of India Limited (ECIL), Bharat Electronics Limited (BEL), ITI Limited, Telecommunications Consultant India Limited (TCIL) and Central Electronics Limited (CEL), etc.
- 2. The Complete bid addressed to the Director, shall be submitted at Reception of Administration Block latest by 3:00 PM on 30/11/2022. Bid has to be dropped in the Tender box kept at reception of Administrative Block of NIHFW, Munirka, New Delhi-67. Bid has to be submitted in a sealed envelope super scribed as "Strengthening of Security Arrangements by Installation of Integrated CCTV Surveillance System in NIHFW". No Bid will be allowed after the above date and time. The Bid document duly signed on each page should be submitted in one envelope marked as EMD and another envelop marked as Commercial/Financial Bid with entire bid documents including all Annexures. The EMD and Commercial/Financial bid with entire bid documents including all Annexures shall be submitted in third envelope (large size) marked on envelope as "Strengthening of Security Arrangements by Installation of Integrated CCTV Surveillance System in NIHFW"
- 3. The specifications, component for installation of CCTV surveillance system are mentioned in Annexure-A (II) in the tender document. These are minimum technical specifications. The bidders may quote products/services of higher specifications with proven performance.
- 4. The interested bidders (CPSU's) are also advised to visit site/premises for:
 - a. Site Survey before bidding, in case they wish so.
 - b. To see the site conditions before quoting the price.
 - c. To draw/design the solution as per site requirement.

d. To take notice of the site/operational conditions.

A final plan for location/installation of CCTV cameras inside & outside will be submitted by the bidder (CPSU''s) before commencement of work within 15 days from the date of award of work.

- 5. Scope of Works: The Scope of work has been covered in the Annexure-A (III). However, the Successful Bidder shall be responsible to complete the works in all respects and in doing so, provide/supply all facilities not covered above, but nevertheless required for the satisfactory performance of the complete system. Detail Scope of the work includes survey of all the locations, delivering the Bill of Quantities (BOQ) to locations, Joint Material inspection at site with site in Charge/his representative, Supply, Installation, Testing & Commissioning, imparting Training to location staff & Handing over the site to the Location in Charge. In addition, the scope also includes Comprehensive Annual Maintenance Contract (CAMC) for Three Years after completion of warranty period of One year.
- 6. The bidder is required to quote for the complete work, though NIHFW has the right to award the work in full or in part or even cancel the tender without assigning any reason.
- 7. Since, this is a turnkey project and the bidder quoting for only one part or partially of the project shall not be considered.
- 8. The Quotation should contain duly filled checklist (Annexure- C) and all the requisite/supporting documents as mentioned.
- 9. Financial Bid: Prices and all taxes to be quoted in the sheet (Annexure- D) along with Annexure- DI & DII of the financial bid.
- 10. Participating agency need to submit the EMD of Rs. 2,00,000/- (Rupees Two Lakh Only) must be in form of Demand Draft from any Scheduled Bank payable at New Delhi in favour of "Director, NIHFW". If agency didn't submit the EMD, agency bid would be summarily rejected.
- 11. Any deviations in commercial stated anywhere in the Quotation shall not be considered, may render the bid non- responsive and liable to be rejected.
- 12. Quotation should be valid till **90 days** from the last date of Bid submission.
- 13. Warranty: One year from the date of Complete System Handover to the NIHFW. The Comprehensive Annual Maintenance Contract is also required for Three years for complete CCTV system/material installed. The warranty should begin after successful operation of CCTV surveillance system for a period of minimum one month under the supervision of the staff of NIHFW trained by the vendor/s and Comprehensive Annual Maintenance Contract will begin after successful completion of warranty period of One Year.
- 14. Basis of price: The offer should clearly indicate units and rates.
- 15. The approved vendor has to quote considering the location of the cameras and other accessories necessary for successful design, supply, installation testing & commissioning of CCTV Surveillance System in NIHFW, Munirka, New Delhi. And the agency has to give training to the Institute's designated/Authorised staff. The approximate required accessories are indicative in Annexure-A (I) i.e. Details of Items required. All the accessories are intended to install the system

in a successful manner.

- 16. Termination for Default: NIHFW may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or in part: If the Bidder fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the NIHFW; or If the Bidder fails to perform any other obligation(s) under the Contract. If the Bidder, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. For the purpose of this clause: "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution. "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution or a contract to the detriment of the NIHFW and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Purchaser of the benefits of free and open competition. In the event, the Purchaser terminates the Contract in whole or in part, the NIHFW (Purchaser) may procure, upon such terms and in such manner as it deems appropriate, Goods or services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or services. However, the Bidder shall continue the performance of the Contract to the extent not terminated. The contractor/bidder shall not display the photographs & content of the work and also will not take advantage through publicity of the work without written permission of the NIHFW. Non-compliance to this may result in blacklisting of the bidder/contractor/firm.
- 17. Force Majeure: In no event shall either Party have any liability for failure to comply with this Agreement, if such failure results directly from the occurrence of any contingency beyond the reasonable control of the Party, including, without limitation, strike or other Labour disturbance, riot, major power failure, war, natural calamities including but not limited to floods, earthquakes, fire, volcanic eruptions, epidemics, National Emergency, interference by any government or governmental agency, embargo, seizure, or enactment or abolition of any law, statute, ordinance, rule, or regulation (each a " Force Majeure Event"). In the event that either Party is unable to perform any of its obligations under this Agreement because of a Force Majeure Event, the Party who has been so affected shall as soon as maybe, after coming to know of the Force Majeure Event, inform the other Party and shall take reasonable steps to resume performance as soon as may be after the cessation of the Force Majeure Event. If the period of non-performance due to a Force Majeure Event exceeds thirty (30) days, the Party whose ability to perform has been so affected may, by giving written notice, terminate this Agreement.
- 18. Bidders shall have to deposit **Performance Bank Guarantee** (**PBG**) in the form of Demand Draft of any scheduled bank at Delhi in favour of "**Director, NIHFW**". Bid Document is available on NIHFW website i.e. www.nihfw.org & CPPP Portal Website https://eprocure.gov.in/cppp/

Introduction

It is an apex body in the field of health & family welfare programmes and is engaged in Education, Training, and Research & Consultancy services. The Institute Campus is located between DDA Flats, Munirka and Old JNU Campus, New Delhi on an area of approx 32 Acres of land.

TENDER DESCRIPTION

On behalf of The Director, NIHFW, Sealed Tender/bid is invited for installation of CCTV Surveillance system in NIHFW, Munirka from only from the MHA notified Central Public Sector Undertakings (CPSU's) having experience in System Integration for CCTV Surveillance Systems such as Electronics Corporation of India Limited (ECIL), Bharat Electronics Limited (BEL), ITI Limited, Telecommunications Consultant India Limited (TCIL), Central Electronics Limited (CEL) and Broadcast Engineering Consultants India Limited (BECIL), etc. Detail of items required for the project are as per Annexure-A (I). Prices quoted should be F.O.R. Destination, inclusive all viz. levies & taxes, transportation and packaging, loading/unloading & forwarding charges, etc.

The bid is only from the MHA notified Central Public Sector Undertaking's (CPSU's) vide OM NO. D-32018/33/2015-SSO dated 8th Dec, 2015.

INSTRUCTION TO TENDERERS

GENERAL

The selected Govt. PSU to provide the best CCTV surveillance of the Institute office campus as well as residential complex along with 3-year maintenance period i.e. (1-year defect liability period & 3-year Maintenance Services)

The complete bid shall be submitted / dropped in the Tender Box placed at the reception of the Administrative Block at The National Institute of Health & Family Welfare at New Delhi on or before 30/11//2022 up to 3:00 PM.

The work shall be deemed to be similar to deposit work as per CPWD norms and the prescribed norms/rules by the CPWD for deposit work shall be applicable.

APPROACH TO SITE:

The work is located at NIHFW, Office Complex, Munirka, New Delhi - 67

GENERAL DESCRIPTION

The work involved is for P/F/I for making the Institute complete and successful execution for Institute's CCTV surveillance along with <u>3-year maintenance</u> services. The <u>scope of work</u> is as follows.

- Fiber optical cable network is to be spread across the campus (making of optical loop) connecting all
 areas like the Workshop & Maintenance building, Teaching block, NDC, Admin Block, Academic
 Block, Clinic and Laboratory Area, Residential Quarters, Gates among other areas in the campus. The
 network should be such that there is scope for future expansions for additional gates, driveways and other
 areas
- The CCTV Camera system is to be monitored from the Control Room in Workshop & Maintenance Building as well as in the Security Office. The CCTV Camera system is also to be monitored and controlled at the Director room as well as in the office of the maintenance in-charge, Security Gate No.-01. The existing CCTV system is also to be relocated as per requirement and monitored at the control room.
- All the CCTV equipments should be of the approved make to have better compatibility. The equipments should be at least equivalent to the mentioned technical specifications or better than the mentioned technical specifications or as approved by the Officer-In-Charge.
- High Resolution Cameras are required at various office buildings, Gates, corridors, internal roads, driveways, residential quarters and the periphery of the campus. The execution of work i.e. cameras will be installed in two phases.
 - 1) In **Phase-I**, all the entry exits points of the buildings, periphery, internal roads, driveways, parking area and gates will be covered. Movement of vehicles along with images of the driver across all gates inside the campus has to be monitored separately at the control room.
 - 2) In **Phase-II**, the areas inside the buildings like the corridors, lift lobby, staircases, reception, canteens etc. as well as the entry/exit points, terrace (if any) of each building of the residential quarters will be covered.

- Items must be complete with all equipments and required accessories along with necessary power systems, video connector, plugs, sockets and hardware/software, as required for the complete installation of the system under this contract and scope of work.
- The firm should visit the site before quoting their rates, so as to satisfy themselves with all site working conditions/requirements, cable routes etc.
- Recording backup of the cameras should be for approximately 30 days.
- A centralized Power supply with a backup of minimum 30 minutes is required.
- The conduits carrying the cabling of the camera system are to be differentiated.
- Putting of surveillance signage throughout the campus.
- The agency has to provide 01 Year on-site support from the date of installation/handover to the NIHFW. After completion of 1 year from the date of handover, 3 years Complete CAMC with on-site support is provided by the vendor. The Vendor has to provide Weekly visit to ensure that the system is working properly. Any fault has to be resolved within 24 working hours.

CAMPUS VISIT

The bidder is advised to visit/examine the site of work and its surroundings, the methodology to be adopted for execution and availability of all materials and Labour including electric power, water, existing road communication etc. before submission of the tender. They may obtain all the relevant information that would be necessary for preparation/filling of the tender bid by visiting the site at their own expenses.

AMENDMENT OF TENDER DOCUMENTS

At any time prior to the deadline for submission of the bids the Institute may, for any reason, modify the tender documents by suitable amendments.

The amendments pursuant shall be notified in e-mail & uploaded on the Institute's website and shall be binding on them. Tenderers will be required to acknowledge the receipt of any such amendment to the bidding documents, and shall submit the same with their tender duly signed.

TENDER CONDITIONS

- 1. Bid Documents downloaded from website to be signed on each page by authorized representative along with Financial Bid / Proposals.
- 2. All pages of the tender shall be signed at the lower right hand corner, wherever required and stamped by the Tenderer or his representative holding the Power of Attorney / Authorized officer.
- 3. Authority letter issued by the Competent Authority i.e. CMD / MD / Chairman for signing the bid document is required.
- 4. The Award of work, Execution and Completion of work shall be governed by documents consisting of (but not limited to) Letter of Award / Work Order, Bid, MoU and Bid Document. The bidders shall be deemed to have gone through the various conditions while making/ preparing their proposal & submitting the Bid.
- 5. In case, any misrepresentations /falsification are noticed in copies of documents submitted, then the bid submitted shall become invalid. NIHFW shall, without prejudice to any other right or remedy, be at liberty to disallow the agency from future participation.

- 6. The NIHFW will provide all the available inputs to the agencies. However, NIHFW does not assume any responsibility for any loss or financial damages on account of use of such information by the participating agencies. The participating Agencies are advised to collect at their own information for preparation, submission of bids & execution of services before award of work. Further, the Participating agencies shall be responsible for obtaining licenses and permits to carry out all the works in the Institute.
- 7. The Agencies provide professional, objective, and impartial advice and at all times hold the NIHFW's interest paramount, strictly avoid conflicts with other assignments or their own corporate interests and act without any consideration for future work.
- 8. Proposal Validity- The offer shall remain valid for 90 days after the last date fixed for submission of bid including the extension(s) given, if any.
- 9. The agency has to quote the applicable PSU's fees, taxes & duties etc. over the total cost incurred as mentioned in scope of work.
- 10. If applicable any other services may be added or deleted by NIHFW by giving notice.
- 11. The contracting agency should deploy a technical staff having specialized work experience in such field to render proper services of these works i.e. the selected agency will post at least one trained Engineer of concern field to supervise the works.
- 12. The contracting agency will comply CPWD norms for Award & execution of work.
- 13. Agency will be responsible for any damage to the equipment, machinery or system on account of negligence/fault of the contractor's authorized staff and the same will have to be made good at his risk and cost.
- 14. The Institute shall not be responsible for payment of wages or any compensation which may be required to be paid to the worker of the contractor engaged by the Agency consequent upon any injury/mishap.
- 15. While handing over the Building/Services/Equipment/System by the Agency to NIHFW, if any of these are found defective the same shall be made good by the Agency at its own cost.
- 16. Agreement shall be drawn with the successful tenderer. All the required material & labour will be provided by the contractor. All the material should be of reputed make & the sample of material(s) will be approved by the Engineer in charge of the Institute.
- 17. The Institute shall have the right of rejection all or any of the tenders and split the work between two or more parties or may reduce the scope of work and also will not be bound to accept the lowest or any tender and Institute decision in this regard shall be final and binding on all Tenderers. Tenders, in which any of the prescribed conditions is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, shall be summarily rejected.
- 18. The competent authority reserves to itself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 19. Tender should be addressed to the Director NIHFW. Each page of tender should be signed by the contractors.
- 20. The work will be executed as per the terms & conditions given in the tender and then CPWD specifications, norms and guideline etc.

- 21. In case of BIS (formally I.S.I.) codes/specifications are not available; the decision of engineer based on acceptable sound engineering practice and local usage shall be final and binding on the contractor.
- 22. The entire work should be executed under the supervision, monitoring & technical expertise of the successful CPSU and lacuna (if any) found in the pre/post execution of work than the concern CPSU shall be responsible for the same and the agency have to rectify the same.
- 23. The work should be completed within 120 days (4 Months). After the period of 120 days a penalty @ Rs. 1,000/- per day will be imposed and the same will be deducted from the bill of the agency.
- 24. The agency has to install/place the best quality of items as well as workmanship for the execution of work, non compliance may attract penalty of 0.5% of the award value for such each instance, maximum penalty limit is of 10% of contract/tendered value/Award value.
- 25. The Institute will release the first Installment as a deposit advance (As per CPWD guidelines for deposit works) as a part payment and further release/settlement of payment from the running bill made according.
- 26. Tenderer are advised to study the tender documents carefully. Submission of Tender shall be deemed to have been done after carefully study and examination of the Tender document & the site with full understanding of its implications.
- 27. Conditional bids would not be accepted.
- 28. Dropping of two or more bids by a single PSU shall cancel the participation of that CPSU
- 29. At any time prior to the deadline for submission of the bids the Institute may, for any reason, modify the tender documents by suitable amendments.
- 30. The Agency shall make the arrangements of accommodation of their staff deployed in the Institute. No residential accommodation will be provided by the Institute i.e. No provision of staying of labour/supervisor etc. in the Institute.
- 31. Any amendment, addenda or corrigenda to these tender documents, if issued, must also be signed & stamped and submitted along with the tender documents.
- 32. The Services shall be rendered as per the approved engineering codes, practices and CPWD Norms.
- 33. The Tenderer/contractor and his employees shall follow the Security instruction/orders issued by the Institute from time to time and follow all the existing directions of security.
- 34. The agency will not employ any child labour and comply the labour laws/Act.
- 35. The contractor should well behave in decent manner and will not consume alcohol during the working hours and ensure that the deployed labour will also not consume alcohol or any type of drugs.
- 36. CONTRACTOR'S ALL RISK POLICY: As per the site conditions, the CPSU will decide whether the CAR Policy is required for the subject work.
- 37. Various work permits as applicable for the job with reference of safety precautions will have to be obtained from regulatory local bodies, sections of Institute before starting of the works.

- 38. The Contractor will not be entitled for any compensation due to enactment of any law regulation, etc. on account whether the same is/are enforced by state central Govt. during the tenure of the contract. Any other Tax like GST, Sales Tax on works contract, Tax of levy, octori, excise duty etc. on materials or any elements in respect of this contract shall be payable by the contractor and NIHFW will not entertain any claims whatsoever in this respect. The contractor's rates should cater for the same.
- 39. On receipt of the 'letter of acceptance' the successful Tenderer will sign agreement on Rs. 100/- stamp paper while entering into a Contract with Institute and on the date and time to be implemented by the Institute for the purpose. Bidders are requested to sign each page of agreement as token of acceptance.
- 40. DEDUCTION OF INCOME TAX: NIHFW will deduct income tax at source from all the payments to be made to the contractor under this contract in accordance with the provisions of Indian Income Tax Laws as applicable to the contractor from time to time. No interest shall be payable by the Company on the Security Deposit.
- 41. TAXES, DUTIES, LEVIES ETC: The contractor shall be responsible for the payment of all taxes, duties, levies etc. on all material/articles that may be used in this work. Any increase in the aforesaid taxes, duties and levies etc. that may arise during the currency of the contract shall not be paid to the contractor by the Institute.
- 42. To assist the examination, the evaluation and comparison of tenders, NIHFW may at it's discretion ask the tenderer for clarification of any tender including clarification for methodology of execution of items, the rate analysis for the items and all other details as considered essential by Institute. All correspondence to the request for clarification etc. shall be sought, offered or permitted. The above clarification or submission of all the details shall form part of the tender and shall be binding on the tenderers.
- 43. The work shall be generally awarded to the L-1 Agency whose overall Cost; Charges are found lowest as per due process. In case the Lowest Quoted Charges of two or more participating agencies is the same, the decision of the Director will be final on the process/mode of selection/finalization of agency.
- 44. The selected Agency has to follow CVC guidelines for awarding/selection of the work to contractors if the work is not executed by them departmentally. Further, CPSU will ensure the working contractor will not be blacklisted and not indulge in any type of criminal etc. activity.
- 45. The successful agency for the purpose of execution of work, progress review and monitoring, shall submit, a detailed work schedule and PERT / CPM indicating completion of all major activities as per the milestones indicated for completion of such activities.
- 46. The Earnest Money of the unsuccessful tenderers will be returned within 30 days of decision of tender. No Interest shall be payable on the Earnest Money.
- 47. After commissioning of the system, the bidder would inform the buyer/NIHFW in writing for taking over the system and organizing training for the staff nominated by Director, NIHFW.
- 48. After the Qualifying Criteria evaluation is completed, the NIHFW shall notify in writing (e-mail) to those Construction Agencies who have qualified. Construction Agency's may attend the opening of Financial bid
- 49. Technical Clarification: bidder desiring any technical clarification may contact In-Charge (WMS), Workshop & Maintenance Section, NIHFW, Munirka, New Delhi-110067 between 10:00 Hours to 17:00

Hours on any working day up to five days before the bid closing date. However, the tender submission and tender closing dates will remain the same.

- 50. The NIHFW also reserves the right to cancel the contract before installation, if the items of the CPSU are not found satisfactory.
- 51. - 53. Items mentioned in the scope of work of tender documents are tentative quantities like CCTV, optical fiber etc. may be increased or decreased. However, the payment will be made as per the actual work-done.
- 54. Regular preventive maintenance visits shall be made by the firm ONCE WEEKLY to ensure upkeep of the system. Any fault brought to the contractor's/firm's notice either during such routine calls or otherwise informed by Control Room officials, shall be responded within twenty-four working hours. In addition to that, the agency should maintain the record of every visit and workability of equipments and furnish the same at the time of payment.
- 55. A separate log book shall be maintained for recording preventive maintenance.

- 59. <u>Arbitration</u>: In the event of any question, dispute or difference arising under this agreement or in connection therewith (except as to matter the decision of which is specifically provided under this agreement), the same shall be referred to the Director, NIHFW. The Director, NIHFW shall be final decision authority for the any such dispute.
- 60. All the dispute arising due to breach of contract, the jurisdiction will be in Delhi court.
- 61. DIRECTOR, NIHFW RESERVES THE RIGHT TO ACCEPT OR REJECT ANY/ALL TENDER(S) WITHOUT ASSIGNING ANY REASON.

EMD & PERFORMANCE GUARANTEE / SECURITY

Scope of Work

- Fiber optical cable network is to be spread across the campus connecting all areas like the Maintenance workshop building, Teaching block, NDC, Admin Block, Academic Block, Clinic and Laboratory Area, Residential Quarters, Gates among others in the campus.
